## Course details

- 1. Course structure:** 17 units, with 13 core and 4 elective
- 2. Literacy and numeracy requirements:** You will need to have a certain level of English language, literacy and numeracy skills. Please contact us for further information. Support is available through our Adult Community and Further Education courses if you're unable to meet this requirement.
- 3. Materials requirements:** Cultura Training recommends students purchase Basic Personal Counselling 8th Ed. By David Geldard, Kathryn to support their studies. All other course specific materials will be provided by Cultura Training, however students are required to provide their own stationery, including work folders and pens. A materials/resource fee may be charged for course materials at enrolment. You will be advised of fees at enrolment.
- 4. Technology requirements:** You will need to have access to a laptop or computer with reliable internet connection and have an understanding of the use of computers and the internet. If you do not have these skills, please contact us.
- 5. Completion requirements:** Once successfully completed you will be issued with a certificate for this qualification and for unit completion only, a Statement of Attainment will be issued. These will be issued within 30 days.
- 6. Recognition of prior learning:** Recognition of Prior Learning involves a formal recognition of the skills and knowledge you have already achieved through previous studies, work and life experiences. To obtain Recognition of Prior Learning you must satisfy the requirements for the entire unit, not just parts of it. If you believe you qualify, we will formally assess your existing skills and knowledge and determine if they can count towards your qualification and shorten the period of your training. There are fees applicable for recognition of prior learning dependent on units being assessed.
- 7. Credit transfer:** You may be eligible for a credit transfer of units if you have studied before. This means you will not need to repeat a unit if you can provide evidence of successfully completing a unit that is equivalent to a unit currently included in this course. To apply for a credit transfer, please contact us. There is no cost for this service.
